[Rules s10(1)] If I do not provide all necessary documentation and complete the online application (eCAF) before my first Census date, I will not be eligible for a loan. I will be required to pay all my course fees direct to the college. The Census date is the last date I can formally withdraw from any unit to not incur a debt. [Rules s98(2)], iiii My course fees will be reasonably apportioned across a specific number of fee periods and that each period will have at least one census day. [Rules s98(2)k] I must complete the Commonwealth progression requirements when requested at least twice in a year. [Rules s5(2)] I will be required to start repaying my VET Student Loan debt through the taxation system once my income reaches the threshold even if I do not complete my course. [Higher Education Support Act 2003, section 154-20, 25, 30] Information concerning the VET Student Loans process can be found on the college website.
